DEADLINE OF CONSERVATION

ULL will proceed to cancel and carry out the prior suppression of blocking personal data once they fulfill the purpose that justified their treatment. The cancellation of personal data will not be made when the assumptions of articles 26 and 34 of the Law are applicable.

EXERCISE OF ARCO RIGHTS

For the exercise of the rights of access, cancellation, rectification and opposition (ARCO), of your personal data in possession of ULL, we will receive the request either in physical or electronic document, by the means described in the section, "MEDIA OF COMMUNICATION".

Said request must comply with the requirements of art. 29 of the aforementioned law.

- ☞ Name and address, as well as any additional information that may be used to contact you.
- ☞ Documents that prove the identity.
- ☞ Concise and clear description that describes the rights that you wish to exercise, as well as the personal data involved.
- ☞ In the case of requesting rectification of personal data, you must accompany the documentation that supports the request.

The response to your request, will be sent to you within the deadlines set by the Law, provided they are not under the circumstances of exception of article 26 of the law and 75 of the regulations.
